

**Humphrey's Highland Elementary Title I Parent Engagement Plan**

**PART I. General Expectations**

Humphrey's Highland Elementary agrees to implement the following statutory requirements:

- Consistent with section 1118, the school will work to ensure that the required campus Title I Parent Engagement Plan meet the requirements of section 1118(b) of the ESEA, and include as a component, a school-parent compact consistent with section 1118(d) of the ESEA.

- B. the reciprocal understanding of schools and families that support meaningful parent-school partnerships;
- C. that parents are encouraged to be actively engaged in their child's education and school;
- D. that parents are equal partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child; and

E. the carrying out of other activities, such as those described in section 1118 of the ESEA.

**PART II.** Description of how Humphrey's Highland Elementary will implement the required components of the campus Title I Parent Engagement Plan.

1. Humphrey's Highland Elementary will take the following actions to involve parents in the joint development of its campus Parent Engagement Plan under section 1112 of the ESEA:

- Establish the campus Parent Engagement Advisory Council adequately represented by parents of attending children, administrators and Title I personnel. Other council members may include community members and students.
- Annually hold a meeting to review, discuss, and revise the school's Title I Parent Engagement Plan.
  - To increase parent accessibility and participation, these meetings will be offered in English and Spanish. Prior to reviewing, discussing and amending the plan, each meeting will offer parents' training on what Title I entails and the importance of parent input.

2. Humphrey's Highland Elementary will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA:

- Hold committee meetings, composed of parents and school staff, to review the Campus Improvement Plan.
  - Parents who are approved volunteers will be selected to participate on this committee. All trainings that are provided for the campus Site Based Decision Making Team will be offered to the parents participating on the committee. All meetings will be offered in English and Spanish.
- Provide Title I, Part A school staff support in enhancing their School Campus Improvement Plans.
  - Trainings will be held during meetings.
- Administer the Title I campus Parent Engagement Survey designed to identify the type of support, information, and resources that parents' need included in their Campus Improvement Plan and campus Parent Engagement Plan to better support their children's education and become more involved in their school.

3. Humphrey's Highland Elementary will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in the Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting and will encourage them to attend. These informative meetings may include, but are not limited to, the following:

- Meet the Teacher, Open House, and Monthly Parent Meetings; language support will be provided.

4. Humphrey's Highland Elementary will, in a timely manner, provide parents of participating children information about Title I, Part A programs that includes a description and explanation of

the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet:

- Title I, Part A programs at Open House. Information provided to parents will be sent home in student's take home folders to ensure all parents have access to the information. Information will be communicated in Spanish and English during the Open House meeting. Information will be sent home in the students' folders in both Spanish and English.

5. Humphrey's Highland Elementary will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible. These may include, but are not limited to, the following:

- Monthly PI Meetings and Monthly SBDM Meetings; information will be provided in both Spanish and English.

6. Humphrey's Highland Elementary will provide each parent an individualized student report regarding the performance of their child on the state assessment in at least math, language arts and reading by:

- Parents will access student reports through Family Access in Skyward.

7. Humphrey's Highland Elementary will provide assistance to parents of children served by the school, as appropriate, on important topics. These may include, but are not limited to, the following:

- Reviewing and understanding the state's academic content standards.
- Reviewing and understanding the state and local academic assessments including alternative assessments.
- The requirements of Title I, Part A.
- How to monitor their child's academic progress.
- How to be involved in their child's education.
- How to best support your child's reading development at home.
- How to utilize programs at home that are web based.
- The 7 Habits of Highly Effective People.

8. Humphrey's Highland Elementary will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parent engagement. These may include, but are not limited to, the following:

- Library Night/Literacy Night
- Academic Night
- Discovery Center Night
- Skyward Parent Training
- Parent engagement programs (e.g., Parenting Partners, Leader in Me, Monthly Literacy/Math Meetings)

9. Humphrey's Highland Elementary will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools. These efforts may include, but are not limited to, the following:

- Parent participation in Site Based Decision Making Team and Monthly Parent Meetings.

10. Humphrey's Highland Elementary will, to the extent feasible and appropriate, coordinate and integrate Title I parental engagement programs and activities with public preschool and other similar programs (e.g., Head Start, Parents as Teachers, etc.) that encourage and support parents in more fully participating in the education of their children. These efforts may include, but are not limited to, the following:

- Send a letter to incoming preschool parents inviting them to their new campus for an orientation and attend Meet and Greets at our community based preschool programs. Language support will be made available.

11. Humphrey's Highland Elementary will take the following actions to ensure that information related to the school, parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand. These may include, but are not limited to, the following:

- Providing interpreter and translation services at meetings, provide services upon request, and use the language line when needed.

### **PART III. Discretionary Components of the Humphrey's Highland Elementary Title I Parent Engagement Plan**

Humphrey's Highland Elementary may provide discretionary activities that build parents' capacity for engagement in Title I schools and the school system to support their children's academic achievement; these may include, but are not limited to, the following:

- Involving parents in the development of training for teachers, principals, and other educators to improve the effectiveness of that training.
